RELEASE OF LIABILITY

In consideration for the use of the swimming pool facilities and the services rendered by Swim Safe Babies, LLC, including swimming lessons, water safety instruction, use of the bathroom and changing room and the appliances used in conjunction therewith, I release, waive, discharge, and hold harmless Swim Safe Babies, LLC, its employees, agents, officers, directors, volunteers, and Cassie Edelman individually, for myself and my minor child/children, our heirs, assigns, executors and administrators, from any and all liability, damages, judgments, suits, claims, costs, attorneys fees, actions, and causes of action whatsoever, in law or in equity, arising out of or related to any loss, damage, or personal injury that may occur to my minor child/children while participating in any swimming lessons, water safety instruction, or prior to or after any swimming lesson or water safety instruction while on the premises of Swim Safe Babies, LLC.

I do hereby understand and agree to be responsible for my minor child/children while on the premises of Swim Safe Babies, LLC. I understand and agree that, at all times aside from active participation in any swimming lesson, water safety instruction, or other related activity conducted by an instructor of Swim Safe Babies, LLC, whether before or after such participation, I will supervise the actions and activities of my minor child/children on said premises, will keep my minor child/children off and away from any play facilities, including swing sets and/or children's play toys that may be on the premises, and will take all efforts reasonably necessary to keep control of my minor child/children so as to prevent any injury. I have inspected the premises and know the risks and dangers associated therewith, in that unanticipated and unexpected dangers may arise during any activity, and I voluntarily assume responsibility for any risks of loss, property damage, or personal injury that may be sustained, or any loss or damage to property as a result of being engaged in such activity.

It is further agreed and understood that as the parent of my child/children I have total, full, and absolute responsibility for reading and abiding by any and all of the information, rules, and regulations given to us by the instructor of Swim Safe Babies, LLC as to insure that my minor child/children will receive the safest, most effective swim lesson and water safety instruction possible. I understand and agree that by not

following the specific instructions provided by the instructor of Swim Safe Babies, LLC, an accident or injury may result for which I agree to indemnify and hold harmless Swim Safe Babies, LLC, and Cassie Edelman individually, for any such accident or injury suffered by my minor child/children or myself.

It is further agreed and understood that upon the withdrawal of my child/children prior to completion of lessons or instruction, as determined by the instructor, Swim Safe Babies, LLC makes no guarantee whatsoever as to the ability of my child/children to swim or survive any supervised or unsupervised aquatic activity or accident.

I HEREBY WARRANT THAT I UNDERSTAND THAT SWIM SAFE BABIES, LLC MAKES NO GUARANTEE WHATSOEVER AS TO ANY CHILD'S ABILITY TO SWIM OR SURVIVE ANY UNSUPERVISED AQUATIC ACCIDENT EVEN AFTER COMPLETION OF LESSONS OR INSTRUCTION. I UNDERSTAND THAT EVEN UPON COMPLETION OF LESSONS OR INSTRUCTION PROVIDED BY SWIM SAFE BABIES, LLC, I AM ABSOLUTELY AND TOTALLY RESPONSIBLE FOR THE CONSTANT UNINTERRUPTED SUPERVISION OF MY CHILD/CHILDREN ANYTIME HE OR SHE IS IN OR AROUND WATER.

I acknowledge having read the above Release of Liability and that I understand the terms contained therein, am a fully competent adult, and am executing this release on behalf of my child/children and myself for full and adequate consideration fully intending to be bound by the same.
